- The library is preparing for students returning next week and will be returning to regular hours as in the fall; Monday-Thursday 8:00am-9:00pm, Friday 8:00am-5:00pm, Saturday 10:00-6:00pm and close on Sunday.
- The lockers are up and running now. Request for items can be held or pick up location at the lockers. Lockers are 24/7 access outside the library. Let your students know it's now available.
- The library services will continue to be hybrid, in-person, and online. Most of our Librarian are providing services online, research support through Zoom. The Student Research Consultants will be providing research support through online and gradually in-person.
- Renovation projects are in the design phase now for the Center for Academic Success and the Center for Faculty Excellence with tentative plan for opening in summer 2023.
- 75<sup>th</sup> Anniversary Celebration – The library is putting together several exhibits:
  - Bios on founding faculty
  - Historical timelines of the library
  - Mesoamerican artifacts collection
- ORCID – Working with ORSCA and Graduate Studies to create an educational awareness campaign to launch in the fall.

- Related to ORCID, SciVal, a tool that is part of Elsevier. The library licensed SCOPUS from Elsevier that replaced Web of Science. SciVal is a product that allows you to do analytics around scholarly output at various levels. It allows you to do comparisons and benchmarking. There will be a 90-day trial, participants will include library, ORSCA, Institutional Effectiveness, Deans and/or department Chairs. The trial may take place late Spring/early Summer. Sample reports will be provided at future meeting.
